## Foster Guidelines

1. Only designated FPAR members shall approve and place rescued animals into foster homes. Your FPAR foster contact must be notified as soon as possible of any changes in the status of either the animal in your core or the foster home environment.
2. All animals placed in foster care will have been examined by an approved veterinarian, will have been given all necessary immunizations, and unless already done so, will be scheduled to be spayed or neutered as soon as possible.
3. The rescued animal must wear an FPAR pet ID tag at all times, and must be on a leash with harness or in a secure pet carrier when outside of foster home or yard. During transport, the rescued animal must ride inside the car. No animal is to ride in the trunk or back of a truck.
4. All medical expenses will be covered by FPAR while pet is in foster care. We appreciate any willingness to provide the essentials like food, bowls, bedding, crates, transport, etc. **All fosters are to contact an FPAR staff member for approval prior to going to a Veterinarian unless a dire emergency. In case of emergency, take pet to assigned emergency vet and notify your FPAR contact as soon as possible. Palomar Animal Hospital at 760-727-7622 is open 7 days/week and is our preferred Vet. They will list Emergency contact for after-hours care.**
5. An FPAR staff member will be contacted immediately if the animal in your care becomes sick, injured or missing. An FPAR staff member will be contacted immediately if a foster, for any reason, is unable to care for the pet.
6. Ownership of all rescued animals remains with FPAR until such time as proper adoption is completed. No rescued animal may be adopted, transferred, or relinquished without the approval by the authorized representative from FPAR.
7. Only authorized representatives of FPAR rescue organization will conduct interviews, home visits and adoptions. This at times may include appropriate foster personnel.
8. If a foster decides to adopt their foster pet, it is agreed that he/she will pay a predetermined adoption fee within two weeks. The foster will abide by all guidelines on adoption agreement contract.

**Please understand we survive only on these adoption donations and taking a dog and not paying only assures that other dogs we had planned to save will die at the shelter.**

## Release of Liability
